EXHIBIT "A" TO UCC FIXTURE FINANCING STATEMENT

BARRINGTON BANK & TRUST COMPANY, N.A., as Secured Party, GK DST -- RIVER FOREST GROCERY, a Delaware statutory trust, as Debtor

- B.
