Cook County Illinois, to-wit:

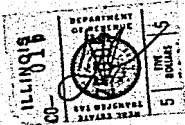

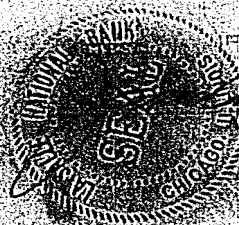
