and behoof forever of said party of the second part. **HILDA HUPPERT, a Spinster**

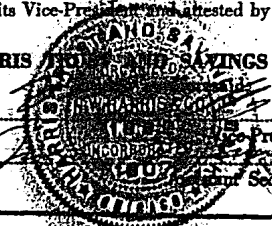
This deed is executed pursuant to and in the exercise of the power and authority granted to and
