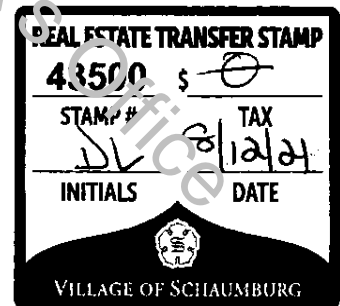

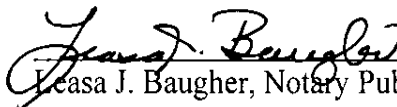

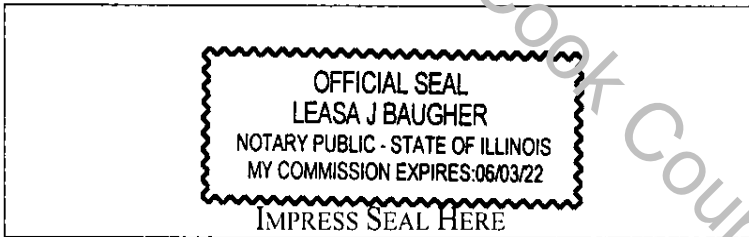

EXHIBIT B

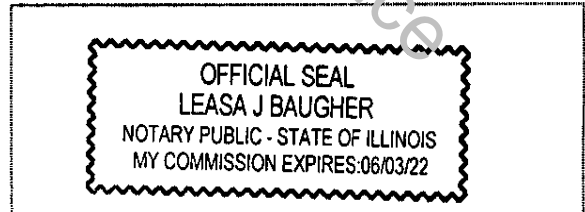
