SUBCONTRACTOR'S CLAIM FOR LIEN

THE UNDERSIGNED LIEN CLAIMANT, Ariel Wagner, Agent of AMERICAN BUILDERS AND CONTRACTORS SUPPLY CO., INC. - ABC SUPPLY CO., INC., One ABC Parkway Beloit, Wisconsin 53511 hereby files a claim for Mechanics Lien against J H SPELL & ASSOCIATES (hereinafter referred to as "Contractor") and COVENANT HOUSE ILLINOIS QALICB LLC (hereinafter referred to as "Owner"), and all other persons having or claiming an interest in the below described real estate, and states as follows:

1. On May 04, 2021, Owner owned the following described land in the County of Cook, State of Illinois, to wit:

Commonly known as 2934 W Lake Street Chicago, Illinois 60612 and having the following permanent index number 16-12-314-059-0000 and hereinafter together with all improvements referred to as the "premises";

2. On information and belief, on or about May 04, 2021, Owner, Owner's Tenant or one knowingly permitted by the Owner to do so entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction of repairs, alterations and improvements to and for the benefit of the premises;

3. On May 04, 2021, Contractor made a subcontract with lien claimant to furnish and supply labor, materials and equipment to Roofing and/or other exterior building materials and products in the amount of \$30,000.00 (Thirty Thousand Dollars and Zero Cents) for said improvement;

4. At the special instance and request of Contractor, lien claimant furnished extra and additional materials to and extra and additional labor for said premises in the amount of \$0.00 (Zero Dollars and Zero Cents)

5. On May 20, 2021, lien claimant substantially completed all work contracted to be done including labor, materials to the value of \$30,000.00 (Thirty Thousand Dollars and Zero Cents) [except that from time to time thereafter lien claimant has, at the request of COVENANT HOUSE ILLINOIS QALICB LLC and/or J H SPELL & ASSOCIATES, returned to the premises to perform certain completion work, the last occasion being on or about May 20, 2021;

6. Owner, or the agent, architect or superintendent of Owner (cannot, upon reasonable diligence, be found in said County) (do not reside in said County);

7. On information and belief, the labor, materials, supplies, equipment and services for said work and in the



improvement of the aforementioned premises performed and supplied by lien claimant was done with the knowledge and consent of the Owner of the beneficial interest in the above named Trust holding record title to the premises;

Contractor is entitled to credits on account leaving due, unpaid and owing to lien claimant, after allowing all credits, the sum of \$28,590.05 (Twenty Eight Thousand Five Hundred and Ninety Dollars and Five Cents) for which, with interest, lien claimant claims a lien on the premises and improvements and to monies or other considerations due or to become due from Owner under said contract between Contractor and Owner;

9. Notice has been duly given to Owner, and persons otherwise interested in the above described real estate, as to the status of the undersigned as subcontractor as provided by The Mechanics Lien Act (Ill. Rev. Stat. ch. 82, §§ 5 and 24 (1991); 770 ILCS 60/5 and 60/24 (1992).

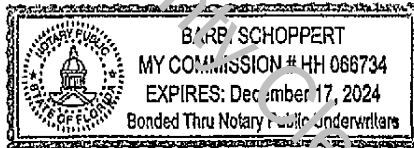
