This case coming to be heard on the Department of Transportation of the State of Illinois's ("IDOT") Agreed Motion for Entry of Order Vesting Title and for order of default against Unknown Owners and Non-Record Claimants, due notice having been given, and the Court, having been fully advised in the premises,

#### **HEREBY FINDS:**

1. On June 3, 2021, the Court entered an order pursuant to 735 ILCS 30/20-5-10 setting preliminary just compensation at \$62,2500.00. IDOT seeks to acquire (a) fee simple title in Parcel 0LA0011, legally described on Exhibit A, and (b) two temporary easements for construction purposes for a period not to exceed five years from the date of vesting of title or until completion of construction operations, whichever occurs first, across and upon real property designated as Parcels 0LA0011TE-A and 0LA0011TE-B, described on Exhibits B and C, respectively.

- 2. IDOT deposited the preliminary just compensation of \$62,250.00 with the Cook County Treasurer on July 22, 2021.
- 3. Unknown Owners and Non-Record Claimants have failed to appear or otherwise plead after proper service by publication.

#### IT IS THEREFORE ORDERED:


- A. IDOT's Motion is Granted.
- B. Pursuant to 735 ILCS 30/20-5-15, the Department of Transportation of the State of Illinois is vested with the following property rights:
  - 1. Fee simple title to the real property designated as Parcel 0LA0011.
  - 2. Two temporary egacinents for construction purposes for a period not to exceed five years from the date of vesting of title or until completion of construction operations, whichever occurs first, across and upon real property designated as Parcels 0LA0011TE-A and of A0011TE-B.
- C. IDOT is authorized to take immediate possession of the property rights described in Paragraph B of this Order, and to exercise immediately all the property rights now vested in IDOT.
- D. Judgment by default pursuant to 735 ILCS 5/2 1301(d) is entered against defendants Unknown Owners and Non-Record Claimants.
