### LOAN MODIFICATION AGREEMENT Providing for Fixed Interest Rate

Borrower (s): ISSAC THOMAS

The debtor(s), ISSAC THOMAS and PHH Mortgage Corporation through the servicer of the underlying mortgage loan agreement, PHH Mortgage Corporation, have agreed to modify the terms of said underlying mortgage loan agreement. PHH Mortgage Corporation is the owner of the loan and retains all rights to collect payments as per the underlying mortgage loan agreement. PHH Mortgage Corporation, remains servicer for said underlying mortgage loan agreement.

This Loan Modification Agreement ("Agreement"), made this 25th day of August, 2021 ("Modification Agreement Date"), between ISSAC THOMAS ("Borrower") and PHH Mortgage Corporation, Lender/Servicer or Agent for Lender/Servicer ("Lender"), amends and supplements (1) the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") dated 07/25/2011 and recorded in the Records of Cook County, IL and (2) the Note, bearing the same date as, and secured by, the Security Instrument (collectively "Loan Documents"), which covers the real and personal property described in the Security Instrument and defined therein as the "Property", located at

the real property described being set forth as follows:

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

#### Representations:

- Borrower is experiencing a financial hardship and as a result, 1) is or will be in default under the Loan Documents and 2) doer, not have sufficient income or access to sufficient liquid assets to make the monthly mortgage payments due under the Loan Documents.
- Under penalty of perjury, borrower provided Lender with full and complete information that, when provided, accurately stated borrower's income, expenses, and assets. To the extent requested by Lender, borrower provided documents that supported that information.
- 3. Borrower has met an the requisite conditions necessary for a permanent modification.
- Borrower currently has sufficient income to support the financial obligations under the Loan Documents, as modified by this Agreement.

- Lender has no obligation to make any nodification of the Loan Documents if any of the requirements under this

- 2. Prior to the Modification Effective Date of 09//11/021, if Lender determines that any of the representations above are no longer true and correct or any prerequisited are not met, 1) the Loan Documents will not be modified, 2) this Agreement will not be valid, and 3) Lender will have all of the rights and remedies provided by the Loan Documents.
- The Loan Documents will not be modified unless and un'il 1) Lender approves this Agreement and 2) the Modification Effective Date has occurred.

#### **Modified Loan Terms:**

- 1. If all of borrower's representations above continue to be true and correr, and all preconditions to the modification set forth above have been met, the Loan Documents will automatically become modified on 09/01/2021 ("Modification Effective Date") and all unpaid late charges that remain unpair will be waived. If borrower has failed to make any payments that are a precondition to this modification or receipt of clear title is not received, this modification will not take effect.
- 2. The new Maturity Date will be 08/01/2051.
- As of 09/01/2021, the amount payable under the Note and the Security Instrument (the "New Principal Balance")
  is U.S. \$219,859.08, consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest and other
  amounts due and owing thereunder.
- 4. The New Principal Balance of the Note will include amounts and arrearages that are past due as of the Modification Effective Date (including, but not limited to, unpaid and any previously deferred principal and interest, Sees, escrow advances and other costs, collectively, "Unpaid Amounts") excluding any fees, costs and/or corporate advances not added to the account as of the Modification Agreement Date and amounts not added to the New Principal Balance due to investor and/or mortgage insurer restrictions less any amounts paid to the Lender but not previously credited to the Loan. Any amounts not added to the New Principal Balance will remain on the account until paid and will become due when the interest-bearing balance is paid in full or upon maturity as applicable pursuant to State or Federal law.
- 5. Borrower understands that by agreeing to add these amounts to the outstanding principal balance, the added amounts accrue interest based on the interest rate in effect under this Agreement. Borrower also understands that this means interest will now accrue on the unpaid interest that is added to the outstanding principal balance, which would not happen without this Agreement. The New Principal Balance represents the "Interest Bearing Principal Balance."

- 6. Borrower promises to pay the New Principal Balance, plus interest, and any future fees/costs to the order of the Lender. Interest will be charged on the Interest Bearing Principal Balance at the yearly rate of 3.25%, beginning 09/01/2021. Borrower promises to make monthly payments of principal and interest of U.S. \$958.42, beginning on 10/01/2021 and continuing thereafter on the same day of each succeeding month until principal and interest are paid in full. Borrower promises to also pay any applicable monthly escrow payments as outlined in this Agreement. The initial monthly escrow amount is \$1,330.73. The yearly rate of 3.25% will remain in effect until principal and interest are paid in full. If on 08/01/2051 (the "Maturity Date"), Borrower still owes amounts under the Note and the Security Instrument, as amended by this Agreement, Borrower will pay these amounts in full on the Maturity Date. Borrower agrees to pay in full all amounts still owed under the Note and the Security Instrument by the earliest of: (i) The date Borrower sells or transfers an interest in the Property, (ii) The date Borrower pays the entire interest Bearing Principal Balance, or (iii) the Maturity Date.
- 7. Borrower promises to pay the New Principal Balance, plus interest, to the order of Lender. Interest will be charged on the Unpaid Principal Balance at the yearly rate of 3.25%, from 09/01/2021. Borrower promises to make monthly payments of principal and interest of U.S. \$958.42, beginning on 10/01/2021, and continuing thereafter on the same day of each since eding month until principal and interest are paid in full, including, but not limited to when Borrower pays off the loan at the time when the property is sold, transferred, refinanced or otherwise paid off. Borrower promises to also have any applicable monthly escrow payments as cutlined in this agreement which are subject to change. The yearly rate of 3.25% will remain in effect until principal and interest are paid in full. If on 08/01/2051 (the "Maturity Date") Borrower still owes amounts under the Note and the Security Instrument, as amended by this Agreement, Borrower will pay these amounts in full on the Maturity Date.

  - b. Original Loan Document Conditions. All covenants, agreements, stipulations, and conditions in the Note and Security Instrument shall be and remain in full force and effect, except as herein modified, and none of the Borrower's obligations or liabilities under the Note and Security Instrument shall be diminished or released by any provisions hereof, nor shall this Agreement in any way impair, diminish, or affect any of cender's rights under or remedies on the Note and Security Instrument, whether such rights or remedies and thereunder or by operation of law. Also, all rights of recourse to which Lender is presently entitled against any property or any other persons in any way obligated for, or liable on, the Note and Security Instrument are expressly reserved by Lender. This Modification constitutes the entire agreement between me and PHH Nortgage Corporation and, supersedes all previous negotiations and discussions between me, PHH Mortgage Corporation and/or PHH Mortgage Corporation predecessors in interest, and neither prior evidence or (any prior or other agreement shall be permitted to contradict or vary its terms. There are no promises turns, conditions, or obligations other than those contained in this Agreement.
- 4. Agreement of Use of Non-Public Information. Borrower authorizes Lender, and Lender's successors and assigns, to share Borrower information including, but not limited to (i) name, address, and telephone including. Borrower will pay to Lender on the day payments are due under the Loan Documents as amended by this Agreement, until the Loan is paid in full, a sum (the "Funds") to provide for payment of amounts due for: (a) taxes and assessments and other items which can attain priority over the Mortgage as a lien or encumbrance on the Property; (b) leasehold payments or ground rents on the Property, if any; (c) premiums for any and all insurance required by Lender under the Loan Documents; (d) mortgage insurance premiums, if any, or any sums payable to Lender in lieu of the payment of mortgage insurance premiums in accordance with the Loan Documents; and (e) any community association dues, fees, and assessments that Lender requires to be escrowed. These items are called "Escrow Items." Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. Borrower shall pay Lender the Funds for Escrow Items unless Lender waives Borrower's obligation to pay the Funds for any or all Escrow Items. Lender may waive Borrower's obligation to pay to Lender Funds for any or all Escrow Items at any time. Any such waiver may only be in writing. In the event of such waiver, Borrower shall pay directly, when and where payable, the amounts due for any Escrow Items for which payment of Funds has been waived by Lender and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender may require. Borrower's obligation to make such payments and to provide receipts shall for all purposes be deemed to be a covenant and agreement contained in the Loan Documents, as the phrase "covenant and agreement" is used in the Loan Documents. Mortgage Insurance: Borrower understands that any applicable mortgage insurance premiums on Borrower's Loan may increase as a result of the capitalization which will result in a higher total monthly payment.
