## TRUSTEE'S DEED

THIS INDENTURE, made this 27th day of August, 1970, between THE COSMOPOLITAN NATIONAL BANK OF CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 25th day of May, 1970 and known as Trust Number 19177, party of the first part, and SAMUEL DELISI and HELENE DELISI, his wife, not as tenants in common, but as joint tenants, 5753 North Artesian, Chicago, Illinois, parties of the second part.

WITNESSETH, that said party of the first party, in consideration of the sum of TEN and 00/100 (\$10.00) Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, the following described real estate, situated in Cook County Illinois, to-wit:

Lot 32 (except the South 18.50 feet) and the South Half of Lot 33 in First Addition to Valenti's Sauganash Estates, being a Resubdivision of part of Lots 2, 4 and 5 in Assessor's Subdivision of the North West Fractional Quarter of Section 3, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois;

together with the tenements and appurtenances thereto belonging.

TO HAVE AND TO HOLD the same unto said party of the second part, and to the proper use, benefit and behoof, forever, of said party of the second part, SAMUEL DELISI and HELENE DELISI, his wife, not as tenants in common but as joint tenants

This deed is executed by the party of the first part, as Trustee, as aforesaid, pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed or Deeds in Trust and the provisions of said Trust Agreement above mentioned, and of every other power and authority thereunto existing, SUBJECT HOWEVER, to the liens of all trust deeds and mortgages upon said real estate, if any, of record in said county; all unpaid general taxes and special assessments affecting the said real estate; building lines; building, liquor and other restrictions of record, if any; Zoning and Building Laws and Ordinances; easements of record, if any;
