## SUBORDINATION OF MORTGAGE

THE SUBORDINATION OF MORTG GE dated February 23, 2021 is made and executed among Cornerstone National Bank & Trust Company ("Mortgagee/Suborcinating Bank"); and Cornerstone National Bank & Trust Company, Its Successors and/or Assigns ("Lender").

### NOW THEREFORE THE PARTIES TO THIS SUBORDINATION STATE THE FOLLOWING:

SUBORDINATION. The Subordinated Mortgage and the Subordinated Indebtedness secured by the Subordinated Mortgage is and shall be subordinated in all respects to the Lender's Lien and the Superior Indebtedness, and it is agreed the Lender's Lien shall be and remain, at all times, prior and superior to the lien of the Subordinated Mortgage. Furthermore, Lender is about to lend to Borrower Five Hundred Forty-Eight Thousand Dollars and 00/100 (\$548,000.00) to pay the indebtedness of Borrower to Lender (or other first mortgage to be paid off) and to obtain the release of the first mortgage in favor of Lender and in connection therewith, Borrowers shall give to Lender a Mortgage to secure the loan in the amount of \$548,000.00 and dated within 30 days of February 23, 2021. Recorded as document number 2113118395

DEFAULT BY BORROWER. If Borrower becomes insolvent or bankrupt, this Subordination shall remain in full force and effect.

MISCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Subordination

Existing First Mortgage: If the existing first mortgage in favor of Lender (or other lending institution), as described above, is released in full, then the mortgage in favor of Subordination Bank, shall be and is hereby subjected and subordinated and shall become in all respects subordinate and junior to the lien of the mortgage given by Borrower to Lender as collateral for the loan to pay off the existing first mortgage and to replace it with a mortgage in favor of Lender.

Lender agrees to not increase the principal sum under the mortgage to which the Subordinating Principal Increases: Bank here'y subordinates or to make additional advances of principal under the mortgage, without the written consent of Subordinating Bank. Notwithstanding, Subordinating Bank acknowledges that Lender has a right to interest on the unpaid principal balance of the mortgage, penalties for nonpayment thereof, and a right to recover amount expended for payment of real estate takes, legard insurance and costs incident to foreclosure and such items are included in this subordination.

Amendments: What is written in this Subordination is Mortgagee's entire agreement with Lender concerning the matters covered by this Subordination. To be effective, any change or amendment to this Subordination must be in writing and must be signed by whoever w! oe bound or obligated by the change or amendment.

Authority: The person who signs o'. Subordination as or on behalf of Mortgagee represents and warrants that he or she has authority to execute this Subordin'...on and to subordinate the Subordinated Indebtedness and the Mortgagee's security interest in the Borrower's property if any.
