\*\*and for fifty-nine (59) consecutive monthly payments thereafter with a final installment due February 1, 1976 of \$15,213.51.

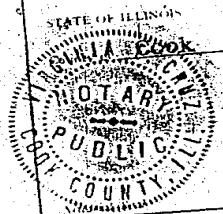
