(i) general real estate taxes not yet due and payable; (ii) special taxes and assessments for improvements not yet completed; (iii) applicable zoning and building laws and ordinances; (iv) covenants, conditions, restrictions, easements and building lines of record; (v) party wall rights and agreement, if any; (vi) encroachments (provided such do not materially adversely affect the intended use of the Purchased Unit); (vii) the Declaration recorded October 6, 2020 as document number 2028016052, as amended from time to time; (viii) the CCR recorded October 6, 2020 as document number 2028016053, as amended from time to time; (ix) the Municipal Code of the City of Chicago; (x) public and utility easements of record; (xi) private easements of record (provided such do not materially adversely affect the intended use of the Purchased Unit); (xii) leases, licenses, overating agreements, and other agreements affecting the common elements of the Property; (xiii) limitations and conditions imposed by the Illinois Condominium Property Act; (xiv) installments due after Closing for assessments levied pursuant to the Declaration; (xv) liens and matters of title ever which the title insurance company is willing to insure without cost to Purchaser; and (xvi) ac's done or suffered by Purchaser, including without limitation, Purchaser's mortgage; provided, bowever, that none of the foregoing covenants, conditions, restrictions, easements or building lines provide for forfeiture or reversion of title in case of breach.
