SECOND MODIFICATION OF MORTGAGE AND OTHER SECURITY DOCUMENTS

THIS SECOND MODIFICATION OF MORTGAGE AND OTHER SECURITY DOCUMENTS (the 'Modification") is made as of the 2nd day of July, 2021, by AFM PROPERTIES, LLC, an illinois limited liability company ("Mortgagor") and FIRST MIDWEST BANK as successor to Bridgeview Bank Group ("Mortgagee").

WHEREAS, Mortgagee has heretof re made a mortgage loan (the "Loan") to Mortgagor and Albert F. Moore, Jr. individually (collectively ("Borrowers") in the original principal amount of One Million and 00/100 Dollars (\$1,00/1,000.00); and

WHEREAS, the Loan is evidenced by a Revolving Line of Credit Mortgage Note by Borrowers to Mortgagee dated as of April 4, 2018, in the amount of **One Million and 00/100 Dollars (\$1,000,000.00)**, as modified by a First Amendment to Mortgage Note by Borrowers dated as of April 3, 2021 (collectively the "Note"); and

WHEREAS, the Note is secured by a Mortgage, Assignment of Rents and Leases and Security Agreement dated as of April 4, 2018, by Mortgagor in favor of Mortgagee, recorded against the real property legally described on Exhibit A attached hereto in the Office of the Recorder of Deeds of Cook County, Illinois, on June 18, 2018, as Document No. 1816941180, as modified by a First Modification of Mortgage and Other Security Documents Agreement dated as of April 3, 2021, by Mortgagor recorded in the Office of the Recorder of Deeds of Cook County, Illinois, on May 6, 2021, as Document No. 2112642156 (collectively the "Mortgage") and other instruments and documents executed by or on behalf of Borrowers and delivered to Mortgagee in connection with the Loan, which are hereinafter collectively referred to as the "Other Security Documents"; and

WHEREAS, Mortgagee and Borrowers are desirous of modifying the Note to extend the Maturity Date; and

WHEREAS, as a condition to such modification, Mortgagee is requiring: (i) this Modification and (ii) a Second Amendment to Revolving Line of Credit Mortgage Note dated of even date herewith executed by Borrowers (the "Note Amendment") whereby the Note is modified to extend the Maturity Date;

NOW, THEREFORE, for and in consideration of Ten and 00/100 Dollars (\$10.00) in hand paid, the mutual covenants and conditions herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto do hereby agree as follows:

- Incorporation of Recitals; Definitions; Conflict. The aforesaid recitals are hereby incorporated into this Amendment as if fully set forth in this Paragraph 1. Any initially-capitalized term used and not defined herein shall have the meaning ascribed to same in the Mortgage and Other Loan Documents. Wherever the terms and conditions of this Amendment conflict with the terms and conditions of the original Mortgage and Other Loan Documents, the terms and conditions of this Amendment shall control. In all other respects the parties do hereby ratify and declare to be in full force and effect the terms and conditions of the Mortgage and Other Loan Documents.
- 1. <u>Modification of Mortgage and Other Security Documents</u>. From and after the date hereof, the Mortgage and the Other Security Documents shall be deemed to secure the Note as modified by the Note Amendment.
- 2. <u>References to Note</u>. From and after the date hereof, any and all references in the Mortgage or the Other Security Documents to the "Note" shall be deemed to refer to the Note as modified by the Note Amendment.
- 3. <u>References to Loan Documents</u>. Any and all references in the Mortgage and the Other Security Documents to the "Loan Documents" shall from and after the date hereof be deemed to refer to such Loan Documents as modified by this Modification.
- 4. <u>Reaffirmation of Representations and Warranties</u>. Mongagor hereby reaffirms as true and correct in all respects, as of the date hereof, any and all representations and warranties contained in the Mortgage and the Other Security Documents.
- 5. <u>Reaffirmation of Covenants</u>. Mortgagor does hereby reaffirm and agree to perform all of the terms, covenants, conditions and obligations applicable to such parties as not forth in the Mortgage and the Other Security Documents as herein modified.
- 6. <u>Laws of Illinois</u>. This Modification shall be covered and construed under the laws of the State of Illinois.
