Covenants, restrictions and easement of record; taxes for the current year.

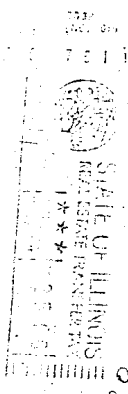

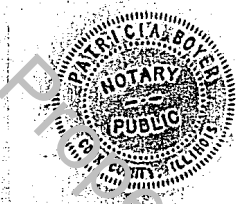
