In consideration of mutual promises and agreements exchanged, and other good and valuable consideration which the parties agree they have received, the Borrower and Lender agree to modify the terms of the Note and Security Instrument as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- As of NOVEMBER 01, 2021, the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$234,915.01, consisting of the unpaid amount(s) loaned to Borrower by Lender plus any interest and other amounts capitalized. Lender Funds for any or all Escrow Items at any time. Any such waiver may only be in writing. In the event of such waiver, Borrower shall pay directly, when and where payable, the amounts due for any Escrow Items for which payment of Funds has been waived by Lender and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender may require.
