payment or partial payment if the payment or partial payments are insufficient to bring the Loan current. Any amounts disbursed by Lender under this Section 9 shall become additional debt of Borrower secured by this Security Instrument. These amounts shall bear interest at the Note rate from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payment.

If this Security instrument is on a leasehold, Borrower shall comply with all the provisions of the lease. Borrower shall not surrender the leasehold estate and interests herein conveyed or terminate or cancel the ground lease. Borrower shall not, without the exp.ess written consent of Lender, alter or amend the ground lease. If Borrower acquires fee title to the Property, the leasehold and the fee title shall not merge unless Lender agrees to the merger in writing.

10. Mortgage Insurance, If Lender required Mortgage Insurance as a condition of making the Loan, Borrower shall pay the premiums required to regintain the Mortgage Insurance in effect. 13. Joint and Several Liability; Co-signers; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. THIS CONDOMINIUM RIDER is made this 8th day of October, 2021 and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to CrossCountry Mortgage, LLC, a Limited Liability Company

(the "Lender")

of the same date and covering the Property described in the Security Instrument and located at: 125 Acadia Cir U.J. 715E, Indian Head Park, IL 60525.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: Wilshire Green East Condominium Association

(the "Condominium Project"). If the owners association or other entity which racts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.
