Third Principal Meridian, in Cook County, Illinois.

Parcel 2:

Grantor also grants to the grantees, their heirs and assigns, as
easements appurtenant to the premises hereby conveyed easement for
ingress and egress as created by and set forth on the plat of subdivision
recorded September 24, 1970 as document no. 21273793.

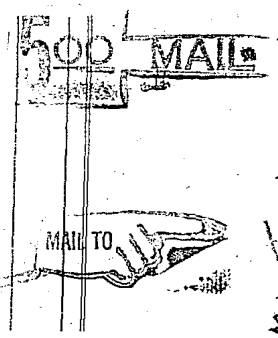
