AGREED FINAL JUDGMENT ORDER

This Matter coming to be heard on the Complaint of THE REGIONAL TRANSPORTATION AUTHORITY, a municipal co-poration, to ascertain the just compensation for the taking of property sought to be taken for improvement purposes as more fully set forth in the Complaint; the Plaintiff, having appeared by and through THOMAS W. CONKLIN, JR.; and

All Defendants having been served as provided by statute and the Court having jurisdiction over this proceeding and over all parties; and

Defendants Unknown Owners and Non-Record claimants, having not entered an appearance in this case, and on motion of the Plaintiff, having been found by the Court to be in default; and

Defendants FIRST MIDWEST BANK, as Trustee under Trust Agreement dated January 11, 2000 known as Trust Number 4295 and Shehdeh Abu-Khalil, an individual, having appeared through counsel and having submitted themselves to the jurisdiction of the Court; and

Due notice of this hearing having been given, and the demand for trial by jury having been waived by the Plaintiff and Defendants; and

The Court having heard and considered the evidence and the representations of Counsel; NOW, THEREFORE, THIS COURT FINDS THAT:

- 1. A stipulation for entry of an Agreed Final Judgment Order has been executed by Plaintiff and Defendants, First Midwest Bank as Trustee under Trust Agreement dated January 11, 2000 known as Trust Number 4295, and Shehdeh Abu-Khalil and filed in this cause.
- 2. The property owner of PIN: 20-09-204-003-0000 with a common address of 5057 S. Wentworth Ave. Chicago, Illinois, which is legally described in Exhibit A attached hereto and incorporated herein by reference, is:

FIRST MIDWEST BANK, AS TRUSTEE UNDER TRUST AGREEMENT DATED JANUARY 11, 2000 AND KNOWN AS TRUST NUMBER 4295; the beneficiary of said trust is STEHDEH ABU-KHALIL.

- 3. Pursuard to an intergovernmental agreement, the Regional Transportation Authority is acquiring the subject property on behalf of the Commuter Rail Division of the Regional Transportation Authority a unit of local government.
- 4. Just compensation to the property owner and interested parties for the full, fee simple taking of the real property identified as PIN: 20-09-204-003-000 and with a common address of 5057 S. Wentworth Ave. Chicago, Illinois is \$950,000.00 in total compensation. That amount includes any claims for interest due from the Plaintiff to the Defendant.
- 5. That the Plaintiff will pay, or cause to be paid, within ninety (90) days of the entry of this order, the just compensation amount of \$950,000.00 to the Cook County Treasurer, and, upon payment of said funds, and at the direction of The Regional Transportation Authority, fee simple title to the real property identified as PIN: 20-09-204-003-0000 and with a common address of 5057 S. Wentworth Ave. Chicago, Illinois will be vested in the Commuter Rall Division of the Regional Transportation Authority, a unit of local government.

IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:

A. that the just compensation to the owner First Midwest Bank as Trustee under Trust Agreement dated January 11, 2000 known as Trust Number 4295 for the full, fee simple taking of real property identified as PIN: 20-09-204-003-0000 with a common address of 5057 S. Wentworth Ave. Chicago, Illinois is \$950,000.00 in total. Said payment is full and final just

compensation due the Defendants from Plaintiff including all claims for interest thereon, and judgement is hereby entered in that amount.

- B. the Plaintiff shall pay or cause to be paid the Just Compensation of \$950,000.00 within sixty (60) days of this Order.
- C. that pursuant to the intergovernmental agreement between the Plaintiff and the Commuter Rail Division of the Regional Transportation Authority, a unit of local government, fee simple tite to the real property identified as PIN: 20-09-204-003-0000 and with a common address of 5057 S. Wen worth Ave. Chicago, Illinois shall be vested in the Commuter Rail Division of the Regional Transportation Authority, a unit of local government, upon payment of the Just Compensation.
- D. that the order of Default heretofore entered against Defendants Unknown Owners and Non-Record claimants on Apr. 14, 2019, be, and the same hereby is confirmed.


