- 4. The Tenants in Common Agreement provides for the following, among other things:
 - a. Restrictions on the ability of the Tenants in Common to convey or encumber their interests in the Property.
 - b. Restrictions on the ability of the Tenants in Common to file a partition action.
 - c. Rights of first refusal.

- d. Rights to place a lien upon a defaulting Tenant in Common's interest in the Property to the extent any non-defaulting Tenant in Common advances money owing by the defaulting Tenant in Common.
- The Tenants in Common intend the terms and provisions of the Tenants in Common Agreement to be covenants running with the land and equitable servitudes expressly for the benefit and burden of, and to be binding upon, each successive owner of any undivided interest in the Property, and upon each person having an interest therein derived through any owner thereof, for the term of the Tenants in Common Agreement.
- This Memorandum is intended only for recording purposes to provide notice of certain terms and conditions contained in the Tenants in Common Agreement and is not to be concirced as a complete summary of the terms and conditions thereof nor meant to amend or modify any terms of the Agreement.
