The Index is the weekly average yield or United States Treasury Securities adjusted to a constant maturity of ***ONE*** (***1****) year, as made available by the Federal Reserve Board. The most recent Index figure available as of 45 days before each Change Date is called the "Current Index". If the Index is no longer available, the Mortgagee will choose a new Index which is based upon comparable information. The Mortgagee will give the Mortgagor notice of its choice.
(3) Before each Change Date, the Mortgagee will calculate the new interest rate by adding **THREE AND ONE-QUARTER** percentage points (****3.25%*****) to the Current Index. The sum will be the new interest rate. Notwithstanding the foregoing, the minimum interest rate charged upon the Note on each Change Date will be ****FOUR AND ONE-QUARTER**** percent (****4.25%*****) per annum.
