joint tenants and not as tenants in common of the Village of Glenwood, in the County of Cook and State of Illinois, the following described real estate

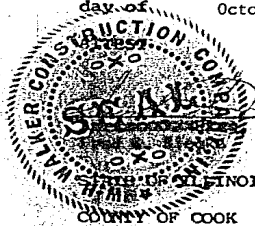
