TEN and No/100ths Dollars, and other good and valuable

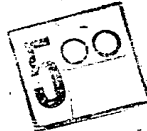

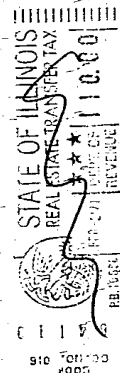
