THIS INDENTURE, made this 11th day of June, 1973, between NORTHWEST NATIONAL BANK OF CHICAGO, a national banking association of Chicago, Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 2nd day of February, 1971, and known as Trust Number 1007, party of the first part, and LEONARD O. KREZ and parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 (\$10.00) dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit: RIDER ATTACHED

Parcel No. 27-A as delineated on the survey of the following described parcel of real estate (hereinafter referred to as "Parcel 1").

That part of Block 2, in Valley Lo-Unit Five, being a Subdivision 1, Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the south line of said Block 2, at a point which is 1006.92 feet east from the southwest corner of said Block 2, and running thence east along said south line of Block 2, a distance of 209.66 feet; thence north along a line perpendicular to said south line of Block 2, a distance of 110.50 feet; thence west along a line 110.50 feet north from and parallel with said south line of Block 2, a distance of 209.66 feet to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at said point which is 1008.92 feet east from the southwest corner of said Block 2, and thence south along said last described perpendicular line, a distance of 110.50 feet to the point of beginning. Commonly known as: 1727 Wildberry Drive, Glenview, Illinois.

This conveyance is made subject to all rights, benefits, easements, restrictions, reservations and covenants contained in said Declaration, and Grantor expressly reserves to itself, its successors and assigns, the rights, benefits and easements set forth in said Declaration for the benefit of all remaining property described in said survey or said Declaration.
