That part of Block 2, in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the south line of said Block 2, at a point which is 1008.92 feet east from the southwest corner of said Block 2, and running thence east along said south line of Block 2 a distance of 209.66 feet; thence north along a line perpendicular to said south line of Block 2, a distance of 110.50 feet; thence west along a line 110.50 feet north from and parallel with said south line of Block 2, a distance of 209.66 feet to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at said point which is 1008.92 feet east from the southwest corner of said Block 2, and thence south along said last described perpendicular line, a distance of 110.50 feet to the point of beginning. Commonly known as: 1727 Wildberry Drive, Glenview, Illinois.

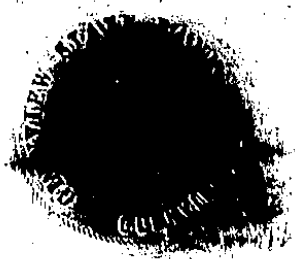
