That part of Block 2, in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing on the south line of said Block 2, at a point which is 1031.48 feet east from the southwest corner of said Block 2, and running thence north along a line perpendicular to said south line of Block 2, a distance of 110.50 feet to a point of beginning at the southwest corner of said part of Block 2 hereinafter described; thence continuing north along said perpendicular line, a distance of 109.50 feet; thence east along a line 220 feet north from and parallel with said south line of Block 2, a distance of 20.09 feet to the southwesterly line of Wildberry Drive; thence southeastwardly along said southwesterly line of Wildberry Drive, being here a straight line, a distance of 9.28 feet to a point of curve; thence continuing southeastwardly along said southwesterly line of Wildberry Drive, being here the arc of a circle convex to the southwest and having a radius of 80 feet, a distance of 62.85 feet to a point of tangent in that south line of Wildberry Drive which is 190.00 feet north from the south line of said Block 2; thence east along said south line of Wildberry Drive, a distance of 103.87 feet, to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at a point which is 1218.58 feet east from the southwest corner of said Block 2; thence south along said last described perpendicular line, a distance of 79.50 feet, to a point which is 110.50 feet north from the south line of said Block 2; and thence west along a line 110.50 feet north from and parallel with said south line of Block 2, a distance of 187.10 feet to the point of beginning. Grantor furthermore expressly grants to the parties of the second part, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and the rights and easements set forth in other Declarations of Condominium Ownership whether heretofore or hereafter recorded affecting other premises in Block 2 in Valley Lo Unit Five Subdivision aforesaid, including, but not limited to, the easements for ingress and egress set forth therein.

This conveyance is made subject to all rights, benefits, easements, restrictions, conditions, reservations and covenants contained in said Declaration, and the grantor expressly reserves to itself, its successors and assigns, the rights, benefits and easements set forth in said Declaration for the benefit of all remaining property described in said survey or said Declaration.
