THIS INDENTURE WITNESSETH, That the Grantor Mae C. Daum, a widow and
not since remarried

of the County of Cook and State of Illinois for and in consideration
of valuable considerations in hand paid, Conveys and Quit Claims unto
EXCHANGE NATIONAL BANK OF CHICAGO, a National banking association, its successor
or successors, as Trustee under a trust agreement dated the 2nd day of
July, 1954, known as Trust Number 17409, the following
described real estate in the County of Cook and State of Illinois, to-wit:

Lot 93 in The Coves of South Barrington, Unit Three being a
Subdivision of the Section 26 and Section 27, Township 42 North,
Range 9 East of the Third Principal Meridian, in Cook County,
Illinois.

Subject To: General taxes for 1973 and subsequent years; Restrictions,
Easements and Covenants of record.

hereinafter called "the real estate."

TO HAVE AND TO HOLD the real estate with appurtenances upon the trusts and for the uses and purposes herein and in the trust agreement set forth.

Full power and authority is hereby granted to said trustee to subdivide and redivide the real estate or any part thereof; to dedicate parks, streets, highways or alleys and to vacate any subdivision or part thereof; to execute contracts to sell or exchange, or execute grants of options to purchase, to execute contracts to convey any terms, either with or without consideration, to convey the real estate or any part thereof to a successor or successors in trust and to grant to such a successor in trust in the title of the little, best, and shortest way; to lease and to let the real estate, or any part thereof, to tenants at will, for a term or for successive terms, to execute leases of the real estate, or any part thereof, for any term or for successive terms, to assign the same to tenants in possession or reversion, by leases or otherwise; to commence in present or future, and upon any terms and for any period or periods of time, and to execute renewals or extensions of leases, and any terms and for any period or periods of time and to execute amendments, changes or modifications of leases and the terms and provisions thereof in any time or times hereafter; to execute contracts to make leases and to execute options to lease and options to renew leases or future interests; to execute contracts to execute grants of easements or covenants of record; to release, convey or assign any right, title or interest in or about or easement appurtenant to the real estate or any part thereof, and to deal with the title to said real estate and every part thereof in all other ways and for such other consideracion as would be lawful for any person owning the title to the real estate to deal with it, whether similar to or different from the ways above specified and at any time or times hereafter.

In no case shall any party dealing with said trustee in relation to the real estate or to whom the real estate or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by the trustee, be obliged to make application of any particular record or return of any instrument or pedigree of any act of the trustee, or be obliged or privileged to inquire of any of the terms of the trust agreement; and every deed, trust deed, mortgage, lease or other instrument executed by the trustee in relation to the real estate shall be conclusive evidence in favor of every person relying upon or claiming under any such conveyance, lease or other instrument, that at the time of the delivery thereof the trust created herein and by the trust agreement was valid and effective, and that the trustee had full power and authority to execute the same according to the terms and conditions of the same, and that the trust agreement or in any amendment thereto and binding upon all beneficiaries.

That the title to the lands contained herein and in the trust agreement or in any amendment thereto and binding upon all beneficiaries, is held in fee simple absolute, subject to the rights of the persons holding the same in accordance with the terms of the trust agreement.

If the title to any of the above lands is now or hereafter registered, the Registrar of Titles is hereby directed not to register or note in the certificate of title or abstracts thereof, or memorial, the words "in trust" or "upon condition" or "with limitations" or words of similar import, in accordance with the statute in such case made and provided.

And the said grantor Mae C. Daum hereby expressly waives and releases any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for the exemption of homesteads from sale on execution or otherwise.




