- of principal or interest, or in case default had occur and continue for three days in the performance of any other agreement of the Mortgagors.

  When the indebtedness hereby secured shall been meduce whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee shall have her in to foreclose the lien hereof, there shall have all other rights provided by the laws of Illinos for the enforcement of a mortgage debt. In any unit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and extense which may be pad or incurred to one behalf of Trustee on holders of the note for which may be estimated as to items to be expended after entry of the decrees of procuring all such abstracts of title, title searches and examinations, guarantee policies. To irrens certificates, and similar data and as arrances with respect to title as Trustee or holders of the note may deem to be reasonably necessars either to prosecute such soit or to essential earlies and expenses of the nature in this paragraph mentioned shall become so much additional indebtedness secured hereby and immedial else ice and payable, with interest thereon at the rate of seven per cent per to probate and bankruptes proceedings, to which either of them shall is a fair, either as plantiff, claimant or defendant, by reason of this Trust Deed or any indebtedness hereby secured or (b) preparations for the colimer term into any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced.
