That part of Block 2, in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing on the south line of said Block 2, at a point which is 1031.48 feet east from the southwest corner of said Block 2, and running thence north along a line perpendicular to said south line of Block 2, a distance of 110.50 feet to a point of beginning at the southwest corner of said part of Block 2 hereinafter described; thence continuing north along said perpendicular line, a distance of 109.50 feet; thence east along a line 22J feet north from and parallel with said south line of Block 2, a distance of 20.09 feet to the southwesterly line of Wildberry Drive; thence southeasterly along said southwesterly line of Wildberry Drive, being here a straight line, a distance of 9.28 feet to a point of curve; thence continuing southeasterly along said southwesterly line of Wildberry Drive, being here the arc of a circle convex to the southwest and having a radius of 80 feet, a distance of 62.83 feet to a point of tangent in that south line of Wildberry Drive which is 190.00 feet north from the south line of said Block 2; thence east along said south line of Wildberry Drive, a distance of 103.87 feet, to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at a point which is 1218.58 feet east from the southwest corner of said Block 2; thence south along said last described perpendicular line, a distance of 79.50 feet, to a point which is 110.50 feet north from the south line of said Block 2; and thence west along a line 110.50 feet north from and parallel with said south line of Block 2, a distance of 187.10 feet to the point of beginning.
