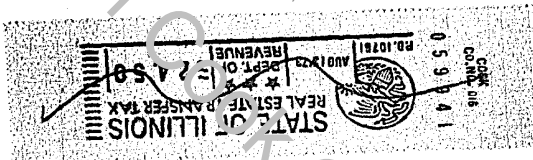
This Indenture, Made this 2nd day of May, 1973

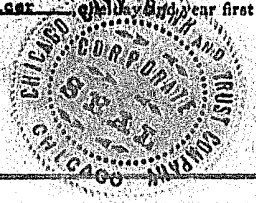
together with the tenements and appurtenances thereunto belonging.

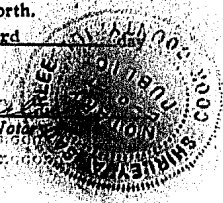
