THIS INDENTURE, made this 30th day of June, 1973, between NORTHWEST NATIONAL BANK OF CHICAGO, a national banking association of Chicago, Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said bank in pursuance of a trust agreement dated the 2nd day of February, 1971, and known as Trust Number 1007, party of the first part, and ELMAN B. SEGAL and

WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 (10.00) ----- dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit: RIDER ATTACHED

Unit No. 26-A as delineated on the survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):

That part of Block 2, in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing on the south line of said Block 2, at a point which is 1031.48 feet east from the southwest corner of said Block 2, and running thence north along a line perpendicular to said south line of Block 2, a distance of 110.50 feet to a point of beginning at the southwest corner of said part of Block 2 hereinafter described; thence continuing north along said perpendicular line, a distance of 109.50 feet; thence east along a line 220 feet north from and parallel with said south line of Block 2, a distance of 70.09 feet to the southwesterly line of Wildberry Drive; thence southeastwardly along said southwesterly line of Wildberry Drive, being here a straight line, a distance of 9.28 feet to a point of curve; thence continuing southeastwardly along said southwesterly line of Wildberry Drive, being here the arc of a circle convex to the southwest and having a radius of 80 feet, a distance of 62.83 feet to a point of tangent in that south line of Wildberry Drive which is 190.00 feet north from the south line of said Block 2; thence east along said south line of Wildberry Drive, a distance of 103.87 feet, to an intersection with a line which is perpendicular to the south line of said Block 2, and which intersects the south line of said Block 2 at a point which is 1218.58 feet east from the southwest corner of said Block 2; thence south along said last described perpendicular line, a distance of 79.50 feet, to a point which is 110.50 feet north from the south line of said Block 2; and thence east along a line 110.50 feet north from and parallel with said south line of Block 2, a distance of 187.10 feet to the point of beginning.
