THIS INDENTURE, made August 25, 1973, between

herein referred to as "Mortgagors," and

MARQUETTE NATIONAL BANK,

a national Banking Association doing business in Chicago Illinois, herein referred to as TRUSTEE, witnesseth:
HAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of TWENTY THOUSAND AND NO/100 Dollars,

WHETHER PHYSICALLY ATTACHED THERETO OR NOT, AND IT IS AGREED THAT ALL SIMILAR APPARATUS, EQUIPMENT, OR ARTICLES HERETOFORE PLACED ON THE PREMISES BY THE COMPANY, WHETHER OR NOT ATTACHED, ARE ALSO CONSIDERED PART OF THE PROPERTY.

To have and to hold the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts hereinafter set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
