WITNESSETH, that said party of the first part, in consideration of the sum of TEN AND NO/10 dollars, and other good and valuable considerations paid, does hereby grant, sell and convey unto said parties of the second part, Not as tenants in common but as joint tenants with right of survivorship, in Cook County, Illinois, to-wit:

The West 1/2 of that part of Lot 35 lying East of the West 33 feet (except the South 33 feet thereof and except the North 45 feet thereof) in George A. Chamber's Subdivision of the West 1/2 of the South West 1/4 of Section 6, Township 31 North, Range 14, East of the Third Principal Meridian.

Grantees reside at: 8321 S. 66th, Chicago, Ill.

Together with the tenements and appurtenances thereto belonging, TO HAVE AND TO HOLD the same unto said parties of the second part, Not as tenants in common but as joint tenants with right of survivorship, per use and benefit and behoof forever of said party of the second part.

Subject to: Taxes for the year 1973.
