That part of Block 2, in Valley Lo-Unit Five being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the north line of said Block 2, at a point which is 1516.93 feet east from the northwest corner of said Block 2, and running thence south along a line perpendicular to said north line of Block 2, a distance of 132.50 feet; thence west along a line 137.50 feet south from and parallel with said north line of Block 2, a distance of 284.70 feet to the easterly line of said Block 2; thence northwardly along said easterly line of Block 2 (being also the westerly line of Waukegan Road), a distance of 122.84 feet to the northeast corner of said Block 2, and thence west along said north line of Block 2, a distance of 275.24 feet to the point of beginning. Commonly known as 1708 Wildberry Drive, Glenview, Illinois.

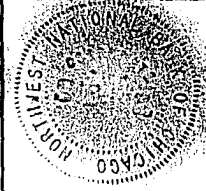
