known as 4611 Vincennes Avenue, Chicago Illinois.

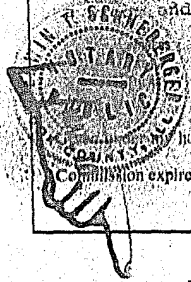
