This Indenture, Made this 2nd day of August 1973

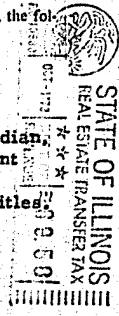

To Have and to Hold the same unto said party of the second part forever, as joint tenants and not as tenants in common.

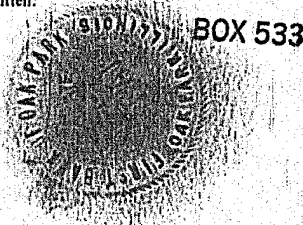
