This Indenture, WITNESSETH, That the Grantor,

MICHAEL R. AUFRICHT AND MARLENE AUFRICHT b1a w1c

of the City of Chicago County of Cook and State of Illinois
for and in consideration of the sum of Ten Thousand Fifty & 7/100 Dollars
in hand paid, CONVEY AND WARRANT to JOSEPH DEZONNA, Trustee
of the City of Chicago County of Cook and State of Illinois
and to his successors in trust hereinafter named, for the purpose of securing performance of the covenants and agreements
herein, the following described real estate, with the improvements thereon, including all heating, gas and plumbing ap-
paratus and fixtures, and everything appurtenant thereto, together with all rents, issues and profits of said premises, situated
in the City of Chicago County of Cook and State of Illinois, to wit:
The North 70 feet of Lots 13 and 14 in Subdivision of Lots 4, 5, and 6 in Bradley
Division and Bradley's Subdivision of Block 9 in Laflin Smith and Dyer's Sub-
division of the North East 1/4 (except 1.28 acres in the North East Corner thereof)
in Section 20, Township 40 North, Range 14 East of the Third Principal Meridian
in Cook County, Illinois.

Hereby releasing and waiving all rights under _____ virtue of the homestead exemption laws of the State of Illinois
In Trust, nevertheless, for the purpose of securing performance of the covenants and agreements herein.

WHEREAS, The Grantor, MICHAEL D. AUFRICHT AND MARLENE AUFRICHT his wife,
justly indebted upon their one principal promissory note bearing even date herewith, payable
NORTHWEST NATIONAL BANK OF CHICAGO, for the sum of Ten Thousand Fifty & 47/100
Dollars (10,050.47) payable in 83 successive monthly instalments each of \$119.65
except the final instalment which shall be paid to or less than the monthly in-
stalments due on the note commencing on the 2^d day of Dec. 1973, and on the same
date of each month thereafter until paid, with interest after maturity at the
highest lawful rate.

In the event of failure to pay when due the amount so due or any part thereof, the holder or holders of said indebtedness, may procure such insurance, or pay such taxes or assessments, or make such payments as may be necessary to pay all prior incumbrances and the interest thereon from time to time; and all money so paid, the principal, "etc.", the same with interest thereon from the date of payment at seven per cent. per annum, shall be so much additional indebtedness secured hereby, and shall bear interest from the date of payment at seven per cent. per annum, until paid, and with interest thereon from time of such loans, at seven per cent. per annum, to be payable by the foregoing persons or by their assigns.

In the event of the death, removal or absence from said Cook, County of the grantees, or of his refusal or failure to act, then
AUGUST G. MERRILL, of the city of Minneapolis, Minnesota, of said County is hereby appointed to be first successor (in this trust) and if no
one else can be found fit and qualified to act, the person whomsoever to be the acting Receiver of Deeds of said County is hereby appointed to be second
successor (in this trust) and if no one else can be found fit and qualified to act, the person whomsoever to be the acting Receiver of Deeds of said County is hereby appointed to be third
successor (in this trust).

Widened the land, and won of them many; this - 22 October 1872.

... of said County is hereby appointed to be first successor in this trust; and if for any like cause said first successor fail or refuse to act, the person who shall then be the acting Recorder of Deeds of said County is hereby appointed to be second successor in this trust; and when all the aforesaid covenants and agreements are performed, the grantor or his successors in trust shall release said extensions to the aforesaid recorder or recorders.


