UNIT NO. 209 as delineated on survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): That part of Lot 2 in Midlands Farms subdivision of that part of the West 1/2 of the North East 1/4 of Section 29, Township 38 North, Range 12 East of the Third Principal Meridian, lying South of 5th Avenue described as follows: Commencing at the point of intersection of the North line of Lot 2 and the West line of the East 175.0 feet thereof; thence Northwesterly along the Northerly line of Lot 2 a distance of 68.0 feet to a point; thence Northwest at an angle of 7 degrees 35 minutes 20 seconds to the left of the prolongation of the last described line a distance of 80.0 feet to a point; thence Southwesterly along a line perpendicular to the last described line a distance of 21.25 feet for a point of beginning; thence continuing Southwesterly along the last described course a distance of 82.0 feet; thence Northwesterly perpendicular to the last described line a distance of 153.0 feet; thence Northeasterly perpendicular to the last described line a distance of 82.0 feet; thence Southeasterly perpendicular to the last described line 153.0 feet to the point of beginning, in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration made by La Salle National Bank, as Trustee under Trust No. 44283, recorded in the Office of the Recorder of Cook County, Illinois, as Document No. 22264463; together with an undivided 2.68 % interest in said Parcel (excepting from said Parcel all the property and space comprising all the Units as defined and set forth in said Declaration and survey).

Grantor also hereby grants to Grantees, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth both in the aforementioned Declaration and in that certain Declaration of Easements, Restrictions and Covenants for Edgewood Valley Community Association recorded as Document No. 22249106 (hereinafter referred to as "Community Declaration"); and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration and Community Declaration for the benefit of the remaining property described therein.

This Condominium Deed is subject to all rights, easements, restrictions conditions, covenants and reservations contained in said Declaration and Community Declaration the same as though the provisions of said Declaration and Community Declaration were recited and stipulated at length herein.
