Subject to: 1973 Real Estate taxes and subsequent years, restrictions and conditions of record.

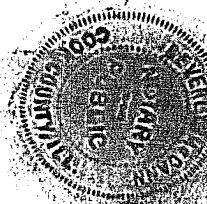
