an undivided five (5%) per cent interest in the following described Real Estate situated in the County of Cook and State of Illinois, to-wit:

That part of Block 13 in subdivision made by Fred M. Jones and others in the West half of Section 29, Township 38 North, Range 14, East of the Third Principal Meridian according to the plat thereof recorded September 29, 1870 in Book 172 of Maps, Page 34, and recorded on March 1, 1872, in Book 1 of Maps, Page 35, described as follows: Commencing at a point on the East line of Ashland Avenue as widened and now used which is 100 feet South of the South line of 74th Street; thence East parallel to the South line of 74th Street a distance of 116.50 feet; thence South parallel with the East line of Ashland Avenue as widened and now used, a distance of 131 feet; thence West parallel to South line of 74th Street to the East line of Ashland Avenue as widened and now used; thence North along the East line of Ashland Avenue as widened and now used, to the point of beginning, in Cook County, Illinois.


