- 1. Mortgagors shall (1) Keep said premises in good condition and repair, without waste; (2) promptly repair, restorables or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said rechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien he use any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request vidence of the discharge of such prior lien to Trustee or to holders of the note; (3) complete within a reasonable time any by ow or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinan permises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal reviously consented to in writing by the Trustee or holders of the note.

14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act of Trustee, Gerald R. Mohrbacher shall be first Successor in Trust and in the event of his or its death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust neventuder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through Mortgagors, and the word "Mortgagors" when used herein shall include all such persons and all persons at any time liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
