

which survey (hereinafter called "Survey") is at ached " "whibit "A" to the Declaration of Condominium Ownership, Easements, Restrictions, Covenants and F. Law, for 175 East Delaware Place, Chicago, Illinois (hereinafter called "Declaration"), recorded on Augus 10, 1973, in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 22434263; togetler with an undivided 0, 11435 percent interest in the Parcel (excepting from the Parcel all of the property and space comprising all Units as defined and set forth in the Declaration and Survey).

Mortgagor also hereby grants to Mortgagee, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set it. in the Declaration, and in the Deed recorded July 30, 1973, as Document No. 22418957, and in the Declaration of Zoni & Restrictions recorded July 30, 1973, as Document No. 22418956, and in the Operating Agreement recorded August 10, 103, 25 Document No. 22434264.
