## TRUSTEE'S DEED

THIS INDENTURE, made this 14th day of December, 1973, between BEVERLY BANK, a banking corporation of Illinois, as successor Trustee, party of the first part, and ROBERT M. CLARK, a Bachelor, 8316 South Western Ave., Chicago, Illinois, party of the second part, WITNESSETH: WHEREAS, Old Beverly Bank (formerly Beverly Bank), a banking corporation of Illinois, was named Trustee under the provisions of a deed or deeds in trust duly recorded or registered and delivered to said Bank pursuant to a trust agreement dated the 15th day of October, 1969, and known as Trust No. 8-2024; and WHEREAS, said trust agreement was amended to provide that any corporate successor to the trust business of any corporate trustee named therein or acting thereunder shall become trustee in place of its predecessor without the necessity of any conveyance or transfer; and WHEREAS, said party of the first part succeeded to the trust business of said Old Beverly Bank on November 21, 1969 and is an authorized successor Trustee pursuant to said trust agreement as amended. NOW, THEREFORE, said party of the first part, in consideration of the sum of Ten Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot 149 in Crest Line Highlands Subdivision of part of the North West quarter and part of the North East quarter of Section 34, Township 38 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

Together with the tenements and appurtenances thereunto belonging, TO HAVE AND TO HOLD the same unto said parties of the second part, and to the proper use, benefit and behoof forever of said party of the second part.
