EXHIBIT "A"

PARCEL 1:

Unit 58C as delineated on the Survey of following described Parcel of Real Listate (hereinafter referred to as Parcel): Lots 46, 49, 52, 53, 54, 55, 56, 57 and 58 in Cedar Run Subdivision, being a subdivision of the Northeast Quarter of Cection 4, Township 42 North, Range 11, East of the Third Principal Meridian accreding to the Plat thereof recorded on October 1, 1971 as Document No. 21660896 in the Cifice of the Recorder of Deeds of Cook County, Illinois which Survey is attached as Exhibit "D" to Declaration of Condominium Ownership made by Tekton Corporation, a Corporation of Delaware, recorded in the Office of the Recorder of Jords of Cook County, Illinois as Document No. 22378213 and amended from time to time together with the undivided percentage interest in the common element in said Parcel (excepting from said Parcel the property and space comprising all the units thereof as defined and set forth in said Declaration and Survey) in Cook County, Illinois.

Easements appurtenant to and for the benefit of Parcol 1 as set forth in the Declaration of Easements dated November 3, 1972 recorded November 3, 1972 as Document No. 22109221.

The acceptance of this conveyance over the Grantees shall be deemed an agreement within the contemplation of the Cormon inium Property Act of the State of Illinois to a shifting of the Common Elemen's pursuant to said Declaration and to all the other terms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each Amended Declaration pursuant thereto.

Party of the first part also hereby grants to parties of the econd part, their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said plorerty set forth in the aforementioned Declaration, and party of the first party les rives to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, commants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
