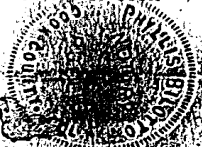

## LEGAL DESCRIPTION RIDER

Unit Number 1-B as delineated on Plat of Survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):

All that part of Lot 6 in Billy Caldwell's Reservation in Townships 40 and 41 North, Range 13 East of the Third Principal Meridian, also that part of Lot 1 in the Subdivision of Lot 1 in Hruby and Company's Subdivision of a part of the Southeast Fractional Quarter of the Southeast Fractional Quarter of Section 31, Township 41 North, Range 13 East of the Third Principal Meridian and also that part of the vacated alley lying South and Southwesterly of Lot 1 aforesaid, described as follows: Commencing on the Northwesterly line of said Billy Caldwell's Reservation at its point of intersection with the Southwesterly line of Milwaukee Avenue; thence South 34° 14' 10" East along the Southwesterly line of Milwaukee Avenue, 50.0 feet to the place of beginning of the tract of land to be described herein; Continuing thence South 34° 14' 10" East along said Southwesterly line of Milwaukee Avenue, 231.77 feet; thence South 55° 45' 50" West at right angles to said Southwesterly line of Milwaukee Avenue, 186.45 feet to its point of intersection with the West line of said Lot 1 extended South; thence "North" in the West line of said Lot 1, 159.57 feet to the most Northerly corner of said Lot 1; thence North 58° 28' 18" West in the Southwesterly line of said Lot 6, 112.55 feet to its point of intersection with a line 50 feet Southwesterly of (as measured along the Southwesterly line of said Milwaukee Avenue) and parallel with the Northwesterly line of said Lot 6; thence North 56° 52' 50" East in said parallel line 142.90 feet to the place of beginning, in Cook County, Illinois,

which Plat of Survey is attached as Exhibit A to Declaration of Condominium made by Chicago Title and Trust Company, a corporation of Illinois, as Trustee under Trust Agreement dated November 23, 1971 and known as Trust No. 58765, recorded in the office of Recorder of Deeds of Cook County, Illinois as Document No. 22211098, together with an undivided 2.718 per cent interest in said Parcel (excepting from said Parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and Plat of Survey.

Grantor also hereby grants to Grantees, their heirs, ~~XXXXXXXXXXXX~~ and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of the property set forth in the Aforesaid Declaration, and Grantor reserves to itself its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in the said Declaration, the same as though the provisions of said Declaration were recited and stipulated at length herein.
