the following described real estate, situated in Cook County, Illinois, to-wit:

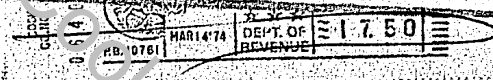

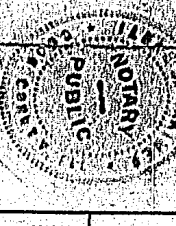
