THAT, WHEREAS First Party has concurrently herewith executed an installment note bearing even date herewith in the Principal Sum of Five Thousand Dollars No/100-----Dollars,

which said Note the First Party promises to pay out that portion of the trust estate subject to said Trust Agreement and hereinafter specifically described, the said principal sum and interest from
on the balance of principal remaining from time to time unpaid at the rate of
6 1/2 per cent per annum in installments as follows: \$135.00

Dollars on the left day of April 1974 and \$135.00

Dollars on the 1st day of each month thereafter until said note is fully paid except that the final payments of principal and interest if not sooner paid, shall be due on the 1st day of Aug. & Sept. 19 77. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each installment unless paid when due shall bear interest at the rate of seven per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Chicago, Illinois, as the holders of the note may from time to time, in writing appoint, and in absence of such appointment, then at the office of RELMO ITALIAN NATIONAL BANK OF CHICAGO, in said City.

NOW, THEREFORE, First Party to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and conditions contained in the Deed of Trust, the record of which is hereby acknowledged, does by these presents grant, remise, release, alien and convey to the Trustee, its successors and assigns, the following described Real Estate situate, lying and being in the COUNTY OF Cook, STATE OF ILLINOIS, to wit:
