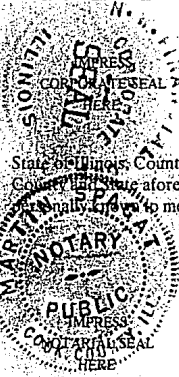
THE GRANTOR N. W. FINANCIAL CORP., a/k/a N. W. FINANCIAL CORPORATION
