## THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promply repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expestly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complet within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make full or partial payments of principal or interest on prior-encumbrances, if any, and purchase, discharge, compromise or settle any tax lieu or other prior lieu or claim thereof, or redeen from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebendenses secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- Mortgagors shall pay each item of indebtedness herein mentioned, both principal and interest, when due "ection of the holders of the principal note, and without notice to Mortgagors, all unpaid indebtedness to the tindept anything in the principal note or in this Trust Deed to the contrary, become due and payable who incit all or interest, or in case default shall occur and continue for three days in the performance of any oth incit all or interest, or in case default shall occur and continue for three days in the performance of any oth incit and the performance of any oth incit.
- 8. The proceeds of any foreclosu. le the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the fore ossus proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms errec constitute secured indebtedness additional to that evidenced by the note hereby secured, with interest thereon as a herein provided; third, all are ossued in the process of the proceeding paragraph and interest remaining unpaid; fourth, any overplus to Morigagors, their heirs, legal representatives or assigns as their rights may appear.
- nterest nereon as nerein provided; firth, an payea, and interest remaining inpaid; court, any overplus to mortgagors, their ners, legar representatives or assigns as their rights may appear.

  9. Upon or at any time after the filing of a court int to foreclose this Trust Deed, the Court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency of Mortgagors at the time of application for such receive, and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not and the Trustee hereumor may e. pointed as such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of sur, force osure suit and, in case of a sale and a deficiency, during the full statutory period for redemption, whether there be redemption or not, a well a, during any further times when Mortgagors, except for the intervention of such receiver, would be entitled to collect such rents, issues an profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation or, or, or, increase during the whole of said period. The Court from time to time may authorize the receiver to apply the net income in his hands in paym nt in whole or in part of: (1) The indebtedness secured hereby, or by any decree foreclosing this Trust Deed, or any tax, special assessment on onthe 7 is making may be received such application is made prior to foreclosytre sale; (2) the deficiency in case of a sale and deficiency.
- 10. No action for the enforcement of the lien of this Trust Deed or of any rovision hereof shall be subject to any defense ood and available to the party interposing same in an action at law upon the new thereby secured.
- 11. Trustee or the holders of the note shall have the right to inspect the ries at all reasonable times and access thereto shall be per ed for that purpose.
- 12. Trustee has no duty to examine the title, location, existence, or condition (it) premises, nor shall Trustee be obligated to this Trust Deed or to exercise any power herein given unless expressly obligated by he terms hereof, nor be liable for any acts or on hereunder, except in case of his own gross negligence or misconduct or that of the agents or emply to of Trustee, and he may require indication to him before exercising any power herein given.
- 13. Trustee shall release this Trust Deed and the lien thereof by proper instrument up a present ion of satisfactory evidence that all intedness secured by this Trust Deed has been fully paid; and Trustee may execute and de a lease hereof to and at the request of any son who shall either before or after maturity thereof, produce and exhibit to Trustee the prepresenting that all indebtedness oby secured has been paid, which representation Trustee may accept as true without inquiry. Where the set is requested of a successor trustee may accept as the genuine note herein described any note which bears a certification purporting to be exted by a prior trustee hereunder or which conforms in substance with the description herein contains of the principal note and which purports to be executed by the persons herein designated as the makers thereof; and where the release is required the throughout the persons herein designated as the makers thereof; and where the release is required the original trustee and be has or executed a certificate on any instrument identifying same as the principal note described herein, he may be presented and which conforms in substance with the described are note which may be presented and which conforms where the release is required the trustee and be herein described any note which may be presented and which conforms which the described are referent to the principal and which purports to be executed by the persons herein designated as makers thereof.
- 14. Trustee may resign by instrument in writing filed in the office of the Recorder or Registrar of Titles in which this instrument shall have
