- 17. MORTGAGORS DO FURTHER COV. NANT AND AGREE that they will not transfer or cause to be transferred or suffer an involuntary transfer of any interest, whether legal or equitable, and whether possessary or otherwise in the rortgaged premises, to any third party so long as the debt secured hereby subsists, without the advance written consent of the holder of the indebtedness, or its assigns, and FURTHER, that in the event of any such transfer by the mortgagors without the advance written consent of the holder of the indebtedness, or its assigns, may, in its or their sole discretion, and without notice to the mortgagor, declare the wire of the debt hereby immediately due and payable.
