18. Hustee may resign by instrument in writing nico in the encorage of the secondary or titles in which this instrument shall have been recorded or filed. In case of the death, resignation, inability or refusal to act, the then Recorder of Deeds of the county in which the premises are situated shall be second Successor in Trust. Any Successor in Trust hereunder shall have the identical title, powers and authority as are herein given Trustee, and any Trustee or successor shall be entitled to reasonable compensation for all acts performed hereunder.

15. This Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagors and all persons claiming under or through the indebtedness or any part thereof, whether or not such persons shall have executed the principal note, or this Trust Deed.
