THIS INDENTURE, made July 1, 1974, between
STEVE W. DICKERSON, a bachelor, and **FLORENCE DICKERSON**, married
to **William C. Dickerson**
herein referred to as "Mortgagors," and **MELROSE PARK NATIONAL BANK**, a National Banking Association
Bank referred to as "TRUSTEE," witnesseth:
THEAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Instalment Note
hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the prin-
cipal sum of **Thirty-One Thousand Five Hundred and no/100-- (\$31,500.00) ---- Dollars**,
evidged by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE OR-
DICH OF BEZNER
and delivered, by which said Note the Mortgagors promise to pay the said principal sum and interest from
on the balance of principal remaining from time to time unpaid at the rate of
7.9 per cent per annum in instalments as follows: Two hundred forty-one and 04/100--
(\$241.04)

Dollars on the 15th day of August 1974 and Two hundred forty-one and 04/100--
(8241.04)
Dollars on the 15th day of each month thereafter until said note is fully paid except that the final payment of principal and interest if not sooner paid, shall be due on the 15th day of July 1999.
All such payments on account of indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal, provided that the principal of each instalment unless paid when due shall bear interest at the rate of 8 per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Melrose Park, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of the First National Bank of Melrose Park, in said City.

NOW, THEREFORE, the Marquisas to secure the payment of a sum principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed and the performance of the covenants and agreements herein contained, by the Marquisas to the trustee, it is hereby agreed, in consideration of the sum of One dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents, CONVINCE and WARRANT unto the trustee its successors and assigns, the following describe, the estate and all of their estate, right, title and interest therein, situated, lying and being in the Village of Melrose Park, COUNTY OF Cook AND STATE OF ILLINOIS,

Lot 543 in Winston Park Unit No. 2, being a Subdivision of part of Sections 2 and 3, Township 39 North, Range 12, East of the Third Principal Meridian, according to the plat recorded July 3, 1886 as Document 16620779 in Cook County, Illinois.

The Makers of this Trust Deed also agree to deposit with the holder of the Instalment Note described herein 1/12 of the annual real estate taxes each month.
